Floor covering consisting of PA composite, which has a nominal area weight of 5170 g/m² and a norminal thickness of 14.5 mm.

Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as flooring covering on steel decks.

Not to be used as an integrated part of horizontal class A division, unless tested as such.
